**To reserve a place for your student:** Return this Re-Enrollment Form and your non-refundable re-enrollment fee of \$500 *per student*, with a *family maximum of \$1000*, to the school office by February 26, 2010. If your money and completed form are submitted on or before February 26, 2010, the school will apply **half** (\$250 *per child* or \$500 *family maximum*) of your re-enrollment fee toward your first month's tuition, and your child's place for the 2010-2011 school year will be secured. If your payment and completed form are not received until after February 26, 2010, then your payment will be applied in its entirety to re-enrollment (*no money will be applied toward 2010-2011 tuition*). Please understand further that after February 26, 2010, your child's re-enrollment is dependent upon both your payment and completed form, and does not guarantee priority seating over new families enrolling in our school. In other words, the only way to guarantee your child's place for next year is to complete and submit this re-enrollment form along with applicable fees on or before February 26, 2010.

**Part IV. Parent/Guardian Financial Commitment**

I agree to read and abide by the purpose and policies of Statesville Christian School as delineated in the applicable parent/student handbook and do hereby request that my child be accepted as a student.

In consideration of Statesville Christian School accepting my child as a student, I will accept full financial responsibility for my child's tuition, fees, and costs assessed for damage to books or school property. It is understood that failure to pay all tuition and fees in a timely manner may result in dismissal and the withholding of grades and transcripts until all financial obligations have been met. Students of parents whose account is in arrears more than sixty days will not be permitted to attend class until the account is made current or arrangements are made in writing with the Business Office to bring the account current. **Students with a past due balance will not be permitted to re-enroll until the account is made current.** Students are enrolled for the entire year; therefore, teacher contracts and budgets are set on this basis.

**Withdrawal Policy**

A student withdrawing prior to September 1<sup>st</sup> will be charged three months tuition unless the school receives written notification **prior to** June 1<sup>st</sup>. After September 1<sup>st</sup>, a student will be charged for all tuition due plus tuition for an additional 30 school days. Report cards and records will not be released with any outstanding balance, including the withdrawal fee remaining at SCS.
